SAMPLE BEQUEST LANGUAGE

A gift to Divine Redeemer Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Divine Redeemer Catholic Church, located in Colorado Springs, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Divine Redeemer Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs and/or the Divine Redeemer Catholic School Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

SPECIFIC BEQUEST: Naming Divine Redeemer Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to Divine Redeemer Catholic Church, located in Colorado Springs, Colorado, the sum of \$_____ to be used for its unrestricted use (or for the support of the Divine Redeemer Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs and/or the Divine Redeemer Catholic School Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

CONTINGENT BEQUEST: Divine Redeemer Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

RETIREMENT PLAN: You may name Divine Redeemer Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, simply enter the *Divine Redeemer Catholic Church* name and *Federal Tax ID #84-0439081* on the *Change of Beneficiary Form*, available from your plan administrator.
