## SAMPLE BEQUEST LANGUAGE

A gift to Holy Family Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Holy Family Catholic Church, located in Leadville, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Catholic Community of Leadville Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

**SPECIFIC BEQUEST:** Naming Holy Family Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to Holy Family Catholic Church, located in Leadville, Colorado, the sum of \$\_\_\_\_\_\_ to be used for its unrestricted use (or for the support of the Catholic Community of Leadville Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

**CONTINGENT BEQUEST:** Holy Family Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

If (insert name) is not living at the time of my demise, I give and devise to Holy Family Catholic Church, the sum of \$\_\_\_\_\_ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the Catholic Community of Leadville Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

**RETIREMENT PLAN:** You may name Holy Family Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, <u>simply enter the Holy Family Catholic Church name and Federal Tax ID #84-0405241</u> on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.
