SAMPLE BEQUEST LANGUAGE

A gift to Holy Rosary Chapel in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Holy Rosary Chapel, located in Colorado Springs, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Holy Rosary Chapel Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

SPECIFIC BEQUEST: Naming Holy Rosary Chapel as a beneficiary of a specific amount from your estate is easy:

I give and devise to Holy Rosary Chapel, located in Colorado Springs, Colorado, the sum of \$_____ to be used for its unrestricted use (or for the support of Holy Rosary Chapel Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

CONTINGENT BEQUEST: Holy Rosary Chapel can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

RETIREMENT PLAN: You may name Holy Rosary Chapel as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, simply enter the Holy Rosary Chapel name and Federal Tax ID #84-0449098 on the Change of Beneficiary Form, available from your plan administrator.
