SAMPLE BEQUEST LANGUAGE

A gift to St. Anthony of Padua Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to St. Anthony of Padua Catholic Church, located in Hugo, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the St. Anthony of Padua Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

SPECIFIC BEQUEST: Naming St. Anthony of Padua Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to St. Anthony of Padua Catholic Church, located in Hugo, Colorado, the sum of \$ _____ to be used for its unrestricted use (or for the support of the St. Anthony of Padua Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

CONTINGENT BEQUEST: St. Anthony of Padua Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

To make a charitable gift from your retirement plan, simply enter the St. Anthony of Padua Catholic Church and Federal Tax ID # 84-1011637 on the Change of Beneficiary Form, available from your plan administrator.
