SAMPLE BEQUEST LANGUAGE

A gift to Vietnamese Holy Martyrs Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Vietnamese Holy Martyrs Catholic Church, located in Colorado Springs, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Vietnamese Holy Martyrs Quasi - Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

SPECIFIC BEQUEST: Naming Vietnamese Holy Martyrs Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to Vietnamese Holy Martyrs Catholic Church, located in Colorado Springs, Colorado, the sum of \$ _____ to be used for its unrestricted use (or for the support of the Vietnamese Holy Martyrs Quasi - Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

CONTINGENT BEQUEST: Vietnamese Holy Martyrs Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

If (insert name) is not living at the time of my demise, I give and devise to Vietnamese Holy Martyrs Catholic Church, the sum of \$ _____ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the Vietnamese Holy Martyrs Quasi - Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

RETIREMENT PLAN: You may name Vietnamese Holy Martyrs Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, simply enter the *Vietnamese Holy Martyrs Catholic Church* name on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.
